Present for the meeting was Dan Hoffman, Bryan Jochimsen, Chad Smith, JoAnn Smith, and Marian Nernberger. Bryan called the meeting to order at 6:00 PM and asked JoAnn to read the minutes from the March meeting. Chad made a motion to accept the minutes as written. Bryan seconded, motion carried.

Bill: The bills were reviewed and Chad made a motion to pay all bills as presented. Bryan seconded. Motion carried.

Fireworks: Lauren Rehbein was present at the meeting requesting permission to set up a stand and sell fireworks in the Township. Chad made a motion to grant permission along with requiring permission and inspection from the Stetsonville fire department. Bryan seconded. Motion carried.

Road report: Discussed were the soft spots throughout the Township along with the milk truck that got stuck on Elm Avenue. Dan reported that Chris Banks gave his two weeks notice that he had accepted another job. Dan said he had accepted his resignation. The Township has received bridge aid in the amount of a little over 29,000 from last year, and still have some coming. Discussed also was Della Lane and North Cardinal to be repaired this year. There are also three culverts shot on the 5th mile of County line Road which will need replacing. Would be nice to take the first 3 miles offer 13 and have Mayville take the last 3 miles. It would also be nice to make a trade with Deer Creek on Crane. Last year's bids were reviewed and Bryan made a motion to place an ad for granite, gravel, breaker rocks, hard rock, sealcoating, blacktop, and dust control. All the bids are to be priced at both by the yard and per ton. Chad seconded. Motion carried. Also discussed were the need to inform residents about plowing snow

across roads.

Centennial community center: Marian reported that the all is going really well and that we are looking for ideas for new events. The polka dance today had a very good turnout.

Large dairy: discussed

Nuisance ordinance: a resident of the town has been warned before to clean up their yard from junk and debris. Bryan made a motion to send this party a registered letter giving them 90 days to comply with the ordinance. Chad seconded. Motion carried.

Milk truck: Bryan made a motion to send Nancy Dick a letter asking if she would use Castle off of Stetsonville A as a route coming and going to her residence during the spring breakup. Chad seconded. Motion carried.

Chuck Zenner: Chuck reported that the County has hired a consultant with the \$50,000 budget to write a business plan for broadband along with writing grants.

Treasurers report: Marian reported the starting balance \$207,290.40 income for the month of \$2609.45. Expenses for this month \$13,340.00 leaving us a balance of hundred and \$193,950.40. Chad made a motion to accept the treasurers report. Bryan seconded. Motion carried.

Chad made a motion to have the next board meeting on May 12th at 6:00 PM. Bryan seconded. Motion carried.

Bryan made a motion to adjourn at 8:10 PM. Chad seconded. Motion carried.
